SHOW INFORMATION AND RULES

FOR THE HEALTH AND SAFETY OF ALL HORSES....

ALL HORSES ON THE WESTWORLD PROPERTY MUST HAVE A 30 DAY VETERINARY HEALTH CERTIFICATE OR A CURRENT (WITHIN ONE YEAR) NEGATIVE COGGINS TEST. ALL VEHICLES HAULING HORSES MUST CHECK IN WITH THE WESTWORLD FEED AND BEDDING STORE UPON ARRIVAL TO HAVE THESE PAPERS INSPECTED. THIS INCLUDES ALL DAY HAULERS. PLEASE COMPLY TO THEIR REQUESTS. WESTWORLD WILL ASK ALL NON COMPLIANT HORSES TO BE REMOVED IMMEDIATELY FROM THE PREMISES.

DAMAGES OR LOSSES: AzRHA Board of Directors, Horse Show Management, Sponsors, or WestWorld will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the horse show, the horse show management, the facility and the sponsors blameless for any loss or accident to themselves, their horse(s) or equipment which may occur from accident, sickness, theft, death or otherwise. YOUR SIGNATURE ON THE ENTRY FORM INDICATES YOU HAVE READ AND UNDERSTAND THIS HOLD HARMLESS AGREEMENT.

NRHA: This show is **APPROVED** by the National Reining Horse Association (NRHA) and the Arizona Reining Horse Association (AzRHA) and will be conducted per the Official Rulebook of the NRHA.

GREEN REINER: This class is NRHA approved and will be held according to their rules and regulations.

NON-NRHA CLASSES: Arabian, Future Reiners, AzRHA Ranch Pleasure, AZRHA Kyle Wood Unrestricted Youth, AZRHA Ladies and Gents Classes. And a full slate of AZRHA Jackpot classes!

ENTRIES: Send the completed Entry Forms and Stall RSVPs to **Kathy Gould at Saddle Up Enterprises, 33410 Road 800, Raymond, CA 93653, email to AZRHA@saddleup-enterprises.com or fax to 559-689-3101.** Entry fees will be collected at the show. Photocopies of NRHA Competition License and current NRHA membership card for owner and exhibitor(s) must accompany entries.

LATE FEE: A \$40.00 Late Fee will be assessed for entries postmarked **after October 3rd, 2016.** *Anyone who enters a class after the draw is posted will be added to the draw at the show management's discretion.*

PAID WARM-UPS: PAID WARM UPS WILL BE HELD TUESDAY, OCTOBER 11TH, from 1:00 PM until approximately 6:00 PM, and then again on WEDNESDAY, OCTOBER 12TH, from 8:00 AM until approximately 6:00 PM. The Equidome will be available for general riding before and after the Paid Warm Ups are finished each evening. The Equidome will be closed and locked after 10:00 pm. **Please contact LYNNE HERMAN AT 520-784-1478 to schedule your paid warm ups.** Rides are \$50.00 for seven (7) minutes in the Equidome. Paid Warm Ups must be scheduled in advance. **PLEASE MAKE ANY CHANGES OR CANCELLATIONS BEFORE 12:00 NOON ON OCTOBER 9TH, 2016. PAID WARM UP SCHEDULE WILL BE POSTED BY 4:00 PM ON MONDAY, OCTOBER 10TH. NO SHOWS WILL BE BILLED.**

REGISTRATIONS: All horses shown in classes designated to be NRHA approved must have a current NRHA Competition License. If your horse does not have a competition license, you can apply for one at the show office. Please see the NRHA handbook and/or website at www.nrha.com for necessary paperwork and eligibility information (back pages of handbook).

MEMBERSHIP REQUIREMENTS: All riders showing in NRHA classes must have a current individual NRHA membership. Show management must inspect the membership cards or membership photocopies prior to issuing entries. If an exhibitor cannot produce a current individual membership card, exhibitors will complete the appropriate application and pay the appropriate membership fees. An exhibitor **MUST PRESENT A CURRENT CARD OR PURCHASE MEMBERSHIP** before they can show. Owners and riders must be current members of AzRHA if they are competing for year-end awards. Memberships, Licenses or Registrations are not required for AZRHA Jackpot Classes and NON-NRHA classes only.

NUMBERS: Each horse will be assigned a separate number to be worn by all exhibitors showing that horse.

PAYMENT: Entry Fees will be due at the show. Checks should be made payable to AzRHA. All NRHA classes will be run according to the rules of the NRHA. If you have questions regarding qualifications for specific classes, please visit their website at www.nrha.com. **CREDIT CARDS ARE NOW ACCEPTED.... PLEASE SEE THE CREDIT CARD AUTHORIZATION FORM BELOW.**

STALLS/BEDDING: STALL FEES ARE \$250.00 AND INCLUDE FIVE (5) BAGS OF SHAVINGS. ALL HORSES WILL BE STABLED IN THE OUTSIDE PERMANENT BARN. SHOW AND CLUB SPONSORS WILL HAVE PRIORITY LOCATIONS OF THESE STALLS. Please see the STALL RSVP form for complete information. Pre-payments are not required for stalls, however, we do ask that you please send in your stall reservation form in advance so we can make sure WestWorld has the correct number of stalls available for this event. This includes Weekend Stalls. We appreciate your cooperation.

Check-in time after 7:00 am on OCTOBER 11TH, 2016. The Equidome will be available for General Riding and Paid Warm Ups will start at 1:00 PM on Tuesday and 8:00 AM Wednesday. All stalls must be vacated by Monday, OCTOBER 17th at 6:00 AM.

WEEKEND STALLS will be available for \$175.00. Move-in time for WEEKEND STALLS will be after 7:00 AM on Saturday, OCTOBER 15TH and they must be vacated by 6:00 AM on Monday, OCTOBER 17th.

Extra bedding is available by calling WestWorld at 480-312-6844.

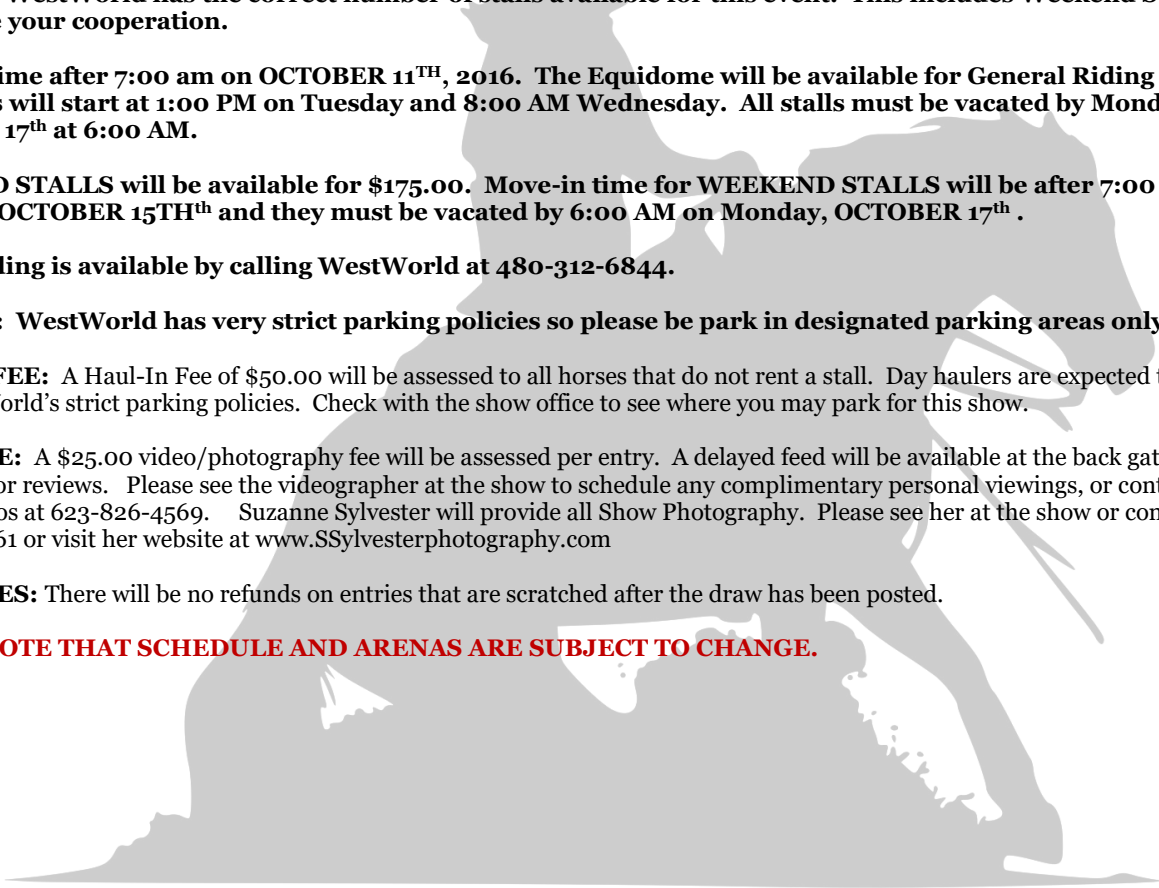
PARKING: WestWorld has very strict parking policies so please be park in designated parking areas only
