## SHOW INFORMATION AND RULES

**NRHA:** This show is **APPROVED** by the National Reining Horse Association (NRHA) and the Arizona Reining Horse Association (AzRHA) and will be conducted per the Official Rulebook of the NRHA.

**GREEN REINER:** This class is NRHA approved and will be held according to their rules and regulations.

**NON-NRHA CLASSES:** Arabian, Future Reiners, AzRHA Ranch Pleasure, AZRHA Kyle Wood Unrestricted Youth, AZRHA Ladies and Gents Classes, RHSF Ride for Bruzzy Cooke.

The **RHSF RIDE FOR BRUZZY COOKE** is a fundraising class which will be held concurrent with other classes during the show. 100% of the funds raised from this class will be donated to this great cause... The Reining Horse Sports Foundation in Bruzzy Cooke's honor. This foundation was created in 1999 and established as a charitable organization for the NRHA. **ENTRIES:** Send the completed Entry Forms and Stall RSVPs (plus stall payments) to **Kathy Gould at Saddle Up Enterprises, 33410 Road 800, Raymond, CA 93653, email to [AZRHA@saddleup-enterprises.com](mailto:AZRHA@saddleup-enterprises.com) or fax to 559-689-3101.** Entry fees will be collected at the show. **Only stall payments are required in advance.** Photocopies of NRHA Competition License and current NRHA membership card for owner and exhibitor(s) must accompany entries.

**LATE FEE:** A \$50 Late Fee will be assessed for entries postmarked **after May 3, 2016.** **Anyone who enters a class after the draw is posted will be added to the draw at the show management's discretion.**

**PAID WARM-UPS:** Please contact AZRHA @ 602-550-9920 to schedule your paid warm ups. Rides are \$50.00 for seven (7) minutes in the Equidome. Paid Warm Ups must be scheduled in advance. **PLEASE MAKE ANY CHANGES OR CANCELLATIONS BEFORE 12:00 NOON ON SUNDAY, MAY 15TH. PAID WARM UP SCHEDULE WILL BE POSTED BY 4:00 PM ON MONDAY, MAY 16TH. NO SHOWS WILL BE BILLED.**

**REGISTRATIONS:** All horses shown in classes designated to be NRHA approved must have a current NRHA Competition License. If your horse does not have a competition license, you can apply for one at the show office. Please see the NRHA handbook and/or website at [www.nrha.com](http://www.nrha.com) for necessary paperwork and eligibility information (back pages of handbook).

**MEMBERSHIP REQUIREMENTS:** All riders showing in NRHA classes must have a current individual NRHA membership. Show management must inspect the membership cards or membership photocopies prior to issuing entries. If an exhibitor cannot produce a current individual membership card, exhibitors will complete the appropriate application and pay the appropriate membership fees. An exhibitor **MUST PRESENT A CURRENT CARD OR PURCHASE MEMBERSHIP** before they can show. Owners and riders must be current members of AzRHA if they are competing for year-end awards.

**DAMAGES OR LOSSES:** AzRHA Board of Directors, Horse Show Management, Sponsors, or WestWorld will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the horse show, the horse show management, the facility and the sponsors blameless for any loss or accident to themselves, their horse(s) or equipment which may occur from accident, sickness, theft, death or otherwise. **YOUR SIGNATURE ON THE ENTRY FORM INDICATES YOU HAVE READ AND UNDERSTAND THIS HOLD HARMLESS AGREEMENT.**

**NUMBERS:** Each horse will be assigned a separate number to be worn by all exhibitors showing that horse.

**PAYMENT:** Entry Fees will be due at the show. Checks should be made payable to AzRHA. **STALL RSVPs and PAYMENTS must be received by Saddle Up Enterprises by MAY 3, 2016.** All NRHA classes will be run according to the rules of the NRHA. PLEASE SEE THE CREDIT CARD AUTHORIZATION FORM BELOW.**

**STALLS/BEDDING:** ALL STALLS INCLUDE SIX (6) BAGS OF SHAVINGS. THERE WILL BE A LIMITED NUMBER OF INDOOR STALLS AVAILABLE IN THE SOUTH HALL OF THE EQUIDOME FOR \$325.00. SHOW AND CLUB SPONSORS WILL HAVE PRIORITY TO THESE INSIDE STALLS. OUTSIDE STALLS WILL BE AVAILABLE FOR \$300.00. Please see the STALL RSVP form for complete stall and payment information. You can order additional bedding by calling WestWorld at 480-312-6844. **Check-in time 12:00 noon ON TUESDAY, MAY 17, 2016. Arena 3 (COVERED) will be open for riding.**

**HAUL IN FEE:** A Haul-In Fee of \$50.00 will be assessed to all horses that do not rent a stall.

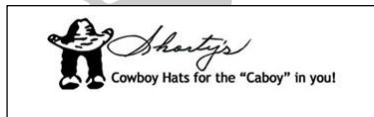
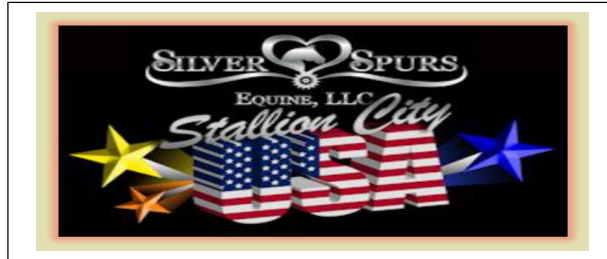

Bruzzy has been a member of the AZRHA for many years and has supported the club and the sport with his contagious enthusiasm. He has touched many lives here in Arizona and beyond and will be deeply missed in the Reining community. One of his favorite sayings was "Never Give Up" and he never did!!
