STALL RESERVATION FORM / DUE AUGUST 5, 2017

- ALL HORSES WILL BE STABLED INSIDE THE NORTH HALL. STALLS DO NOT INCLUDE SHAVINGS.
- STALL FEES ARE \$250.00 for the entire show.
- CLUB SPONSORS WILL HAVE PRIORITY LOCATIONS OF THESE STALLS.
- Pre-payments are not required for stalls, however, we do ask that you please send this STALL RESERVATION FORM in advance so we can make sure WestWorld has the correct amount of stalls set up for this event. This includes Weekend Stalls. We appreciate your cooperation.
- Check-in time after 12:00 noon on August 15, 2017. The Equidome will be available for General Riding after 12:00 noon and Paid Warm Ups will start at 7:00 AM on Wednesday. All stalls must be vacated by Monday, August 21st at 6:00 AM.
- WEEKEND STALLS will be available for \$150.00. Move-in time for WEEKEND STALLS will be after 7:00 AM on Saturday, August 19th and they must be vacated by 6:00 AM on Monday, August 21st.
- Bedding is available by calling WestWorld Feed and Bedding at 480-312-6844, or visit their onsite store.
- The Arizona Sliders IEA Reining Team is proud to offer a pre-bedding and disinfecting service at the show. Pay a small fee of \$20.00 for pre-bedding and/or \$5.00 for disinfecting before you arrive. - **DAY HAULERS MUST PARK OUTSIDE ON THE EAST SIDE OF THE NORTH HALL.**
- **HORSES MAY NOT BE TIED TO TEMPORARY INSIDE STALLS.**

ALL HORSES ON THE WESTWORLD PROPERTY MUST HAVE A 30 DAY VETERINARY HEALTH CERTIFICATE OR A CURRENT (WITHIN ONE YEAR) NEGATIVE COGGINS TEST. ALL VEHICLES HAULING HORSES MUST CHECK IN WITH THE WESTWORLD FEED AND BEDDING STORE UPON ARRIVAL TO HAVE THESE PAPERS INSPECTED. THIS INCLUDES ALL DAY HAULERS. PLEASE COMPLY TO THEIR REQUESTS. WESTWORLD WILL ASK ALL NON COMPLIANT HORSES TO BE REMOVED IMMEDIATELY FROM THE PREMISES.
